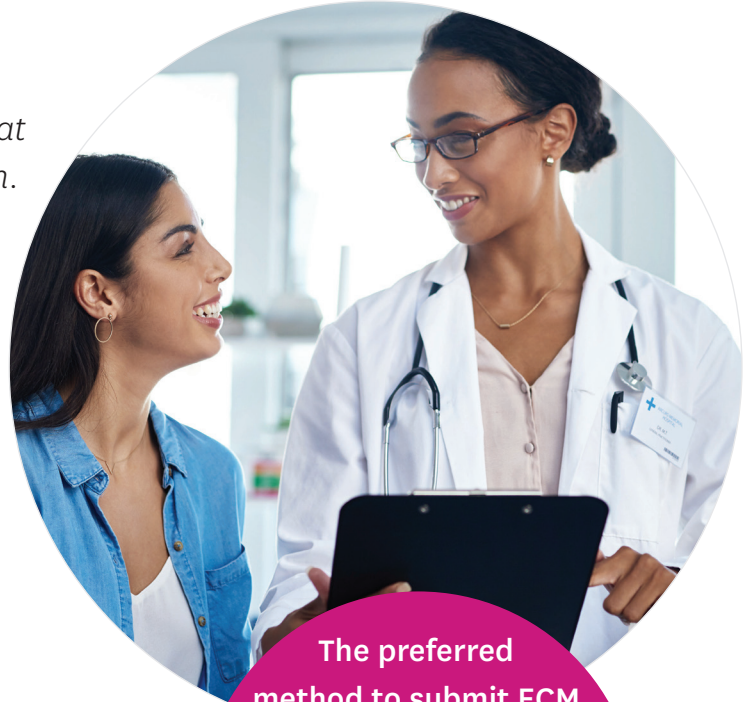


# Use findhelp to Submit ECM Referrals

REFER PATIENTS THROUGH THE PROVIDER  
PORTAL OR DIRECTLY THROUGH FINDHELP

**Enhanced Care Management (ECM)** is a benefit that offers a whole-person approach to care coordination. ECM addresses the clinical and non-clinical conditions of high-need Medi-Cal members for better health outcomes.

Community Health Plan of Imperial Valley expanded its partnership with findhelp, formerly known as Aunt Bertha, to support Enhanced Care Management (ECM) referrals under the CalAIM program. In the United States, findhelp is the largest online search and referral platform to help link people to ECM and/or to no-cost or low-cost services to promote good health.



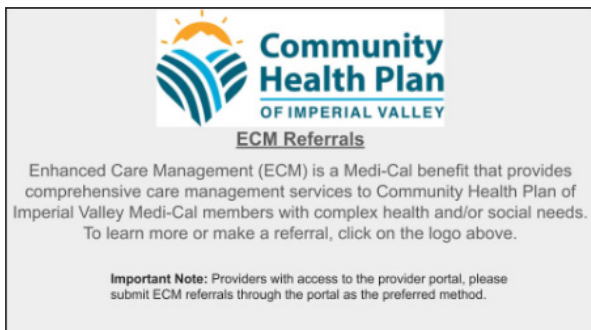
The preferred method to submit ECM referrals is through the provider portal. If you do not have access to the provider portal, follow the steps to the left.

## Complete two screening checklists and a findhelp application

There are three required steps before completing the referral form and the screening application for the Enhanced Care Management Referral Program.

**Step 1:** Complete the *Population of Focus Screening Checklist* to confirm member eligibility in one or more Populations of Focus.

**Step 2:** Complete the *Exclusionary Screening Checklist* to verify member eligibility.

**Step 3:** If the member is eligible for the ECM benefit based on both screening checklists, complete and submit the findhelp screening application shown below.
